

MINOTAGE


(Minoan Meritage) combines the term “merit” (the quality of the grapes) with “heritage” (the centuries-old traditions of winemaking) that we have inherited from the Minoans, Europe’s first great civilization.



Thomas M. Brogan (Ph.D., Bryn Mawr College) is the newly-elected Director of the Institute for Aegean Prehistory (INSTAP), and he has been the Director of the INSTAP Study Center for East Crete since 1997. The foundation annually provides support to more than 60 international projects working on prehistoric material culture. He is a longstanding member of the American School of Classical Studies, for which he often leads student trips to Crete. Since 1989, Tom has worked on numerous Cretan excavations, including several directed by members of the Greek Ministry of Culture (e.g., Pacheia Ammos, Bramiana, Mesorachi, Papadiokampos, and Chryssi). He has also spent the past 35 years tasting Greek wines from the hills of Macedonia to the valleys of the Peloponnese and the rugged slopes of Crete. During that period, Tom also has been fortunate to find unique evidence for wine production in the Minoan towns at Mochlos and Papadiokampos, and help other projects trace Cretan wine production back to the Neolithic.



Al Leonard (Ph.D., University of Chicago) is a Research Associate at the Harvard Museum of the Ancient Near East, and Professor Emeritus in both the Departments of Classical Archaeology and Near Eastern Studies at the University of Arizona. He is an archaeologist who specializes in trade among the cultures of the ancient Mediterranean World, and has directed excavations on Crete as well as in Egypt, Cyprus, Israel, Italy, Jordan, and Portugal. As his *alter ego*, The Time Traveling Gourmet, Al combines his archaeological work with skills acquired at the Culinary Institute of America (Napa, CA), where he was partially supported by a Robert Parker Wine Advocate Scholarship. For more than 20 years, he has been a member of the Society of Wine Educators and the Northern Sonoma County *convivium* of Slow Food International. Al’s latest book, *Mediterranean Wines of Place: A Celebration of Heritage Grapes*, was published by Lockwood Press in 2020.



Kostas Chalikias (Ph.D., Ruprecht-Karls University Heidelberg), a native of Crete, is an archaeologist who has participated since 2002 on several excavations throughout Crete, including Azoria, Chryssi Island, Mochlos, Papadiokampos, Zominthos, and Ierapetra; and was the co-director of the excavation of the Minoan building at Gaidourophas in east Crete. He has been living since 2012 in Philadelphia, where he is currently the Assistant Director of the Institute for Aegean Prehistory while regularly teaching courses on archaeology and ancient art at Arcadia University and other academic institutions in the wider Philadelphia metropolitan area. *Kostas will accompany the tour from May 21st through May 23rd.*

Friday, May 17, 2024: Depart home for Herakleion, Crete, Greece

Saturday, May 18: Arrive Herakleion | Transfer to hotel | PM at leisure | Welcome reception

Upon arrival at Herakleion's Nikos Kazantzakis International Airport (HER), you are met for a private transfer to our hotel. Enjoy some time to relax and settle in. Gather this evening for a welcome reception with wine and *mezzes*, hosted by INSTAP's Tom Brogan and Al Leonard plus your tour manager/local guide. Dinner is on your own. *Overnight at the 5-star [Megaron Hotel](#) (or similar) for three nights.* (R)

Sunday, May 19: Herakleion Archaeological Museum | Vathypetro | Lyrarakis Winery | Herakleion | Welcome dinner

Visit the celebrated Herakleion Archaeological Museum, which houses the world's finest collection of Minoan art and artifacts. Drive 30 minutes to the ancient Minoan estate at Vathypetro, with its 3,500-year-old wine press. Then tour the Lyrarakis Winery and enjoy a tasting and lunch. Return to our hotel in Herakleion and gather this evening for a 10-minute walk along the Venetian harbor walls to a local restaurant for a festive welcome dinner. (B,L,D)

Monday, May 20: Knossos | Miliarakis-MINOS Winery | Archanes | Herakleion

Begin the day with a visit to the legendary, partially-reconstructed Minoan palace at Knossos, rich in imagination thanks not only to its associated myth of the Minotaur and labyrinth but also to the excavation and reconstruction efforts of Sir Arthur Evans in the early 20th century. In addition to your INSTAP experts, the curator of Knossos will join us. We then enjoy a tour and tasting at the Miliarakis/MINOS Winery, joined by the owner. After lunch at a taverna in Archanes, we will tour the village including its small archaeological museum. Return to Herakleion, and gather this evening for a 10-minute walk to a restaurant for dinner. (B,L,D)

The Friends of the INSTAP Study Center was founded in 2004 with the goal of bringing together the Aegean Bronze Age community in the Philadelphia area through lectures by specialists in the field on topics that would be of interest to scholars, students, and the general public.

We raise funds that benefit scholars who use the Study Center and the facilities of the Study Center itself, which is visited and used by hundreds of students, researchers, and volunteers annually.

Tuesday, May 21: Azoria | Short boat ride to Mochlos | Ierapetra

Depart Herakleion, heading east to the remote and rarely visited archaeological site of Azoria, which we will reach by Jeep, ascending a double-peaked hill overlooking the Gulf of Mirabello. Azoria boasts extensive remains of an Archaic Greek city, but the vast site was first occupied in the Final Neolithic and last occupied in the Hellenistic period. After lunch we take a boat ride to the island of Mochlos, where complex archaeological remains ranging from 3000 B.C. to the 10th century A.D. have been found, including a Minoan town (ca. 1700-1430 B.C.) and a Mycenaean village and cemetery (ca. 1400-1250 B.C.). We return by boat and drive south to check-in to our luxury hotel on the coast. (This is where archaeologist Kostas Chalikias joins us for the next couple of days.) Gather for dinner this evening. *Overnight at the 5-star [Numo Ierapetra resort](#) (or similar) for three nights.* (B,L,D)



Wednesday, May 22: Archaeological Museum of Siteia | Zakros | Toplou Monastery & vineyards | Ierapetra

Drive to Siteia to explore its little-visited archaeological museum, with Minoan wine presses from Petras and Papadiokampos; storage jars for wine from Zakros, Petras, and Papadiokampos; drinking equipment from dozens of Minoan sites; and Linear A tablets from Zakros recording wine in the palace. Continue on to visit the Minoan palace at Zakros, followed by lunch at a local taverna on the beach. This afternoon we visit the 14th-century Toplou Monastery and its organic vineyards with Abbot Filotheos Spanoudakis, including a tasting of its special wines. The monastery houses important frescoes, icons, and a museum of religious objects. Return to our hotel in Ierapetra and gather for dinner. (B,L,D)

Thursday, May 23: Gournia | INSTAP Study Center for East Crete | Pefka | Ierapetra


This morning we drive to the well-excavated and well-preserved Minoan town of Gournia, where we may best envision life in a Late Bronze Age (ca. 1500 B.C.) town as we stroll cobbled streets among the ruins of some 50 houses, a small Minoan palace, and a cemetery. Gournia's houses offer a plethora of evidence for wine production. Then tour INSTAP Study Center for East Crete with its Director (and our co-leader), Tom Brogan, to learn about the Center's mission and scholarship program. A local taverna will cater a special lunch at the Center. We then tour the Minoan dye-works at Pefka, and see the wine press at the home of early 20th-century American archaeologist Richard Berry Seager. Return to our hotel in Ierapetra and gather for dinner. (B,L,D)

Friday, May 24: Tylissos | Douloufakis Winery | Herakleion: Historical Museum of Crete, walking tour

Today we return to Herakleion, stopping along the way at ancient Tylissos. This ancient Minoan town includes the ruins of three luxurious Minoan houses, a cistern and an aqueduct with clay pipes, and evidence for elite feasting: dozens of large storage jars, some incised with Linear A, possibly for storing wine; large bronze cauldrons to prepare stews; and miniature frescoes depicting processions and preparations of feasts. We then tour the local family-run Douloufakis Winery and enjoy a wine tasting and lunch. We arrive this afternoon in Herakleion, where we will have a guided tour of the Historical Museum of Crete and then check-in to our hotel. After some time to freshen up, take a walking tour (en route to the




Al Leonard at Douloufakis Winery

restaurant where we will have dinner) focusing on Herakleion's Byzantine, Arab, Venetian, and Ottoman history. *Overnight at the 5-star [Megaron Hotel](#) (or similar) for two nights.* (B,L,D)

Saturday, May 25: Gortyn | Zacharioudakis Winery | Phaistos | Herakleion | Farewell dinner

Drive south this morning to the famous Greco-Roman site of Gortyn, which became the dominant city in the region after Phaistos fell, later becoming the first city on Crete to accept Christianity. We will see its wall with the famous 5th-century B.C. law code and the 6th-century A.D. basilica of St. Titus. Then tour and enjoy wine tastings at Zacharioudakis Winery before having lunch at a taverna in Zaros. Our last Minoan site of the program is the magnificent palace at Phaistos. Return to our hotel in Herakleion and gather this evening for our gala farewell dinner hosted by our INSTAP leaders. (B,L,D)

Sunday, May 26: Fly home


Individual transfers are provided to Herakleion's Nikos Kazantzakis International Airport (HER) for return flights homeward. (B)



MODERATE: Must be able to walk one to three miles per day on mostly flat, but often uneven, terrain.

What to Expect

You must be able to make long walks, unassisted, over uneven terrain and up and down steps. Some sites require strenuous and/or brisk walking or climbing, sometimes with difficult footing. Participants who are not able to walk or stand unassisted for extended periods are kindly advised not to join this tour. All participants are expected to be physically active and not be an impediment to others on excursions, to enjoy traveling as part of a group, and to be ready to experience cultural differences. All participants will be required to follow safety/sanitization protocols set forth by Sponsors/Operator, local staff, and host country laws. If the tour manager decides that a participant cannot visit a site safely or in a timely manner, their judgment will be final. Where possible, an alternate activity may be suggested; additional costs may apply. If you have any questions about your ability to participate, we suggest that you visit your personal physician with this brochure in hand and discuss whether or not this program is appropriate for you. Hotels have been chosen for their excellent locations and generous comfort. Included meals and wine tastings are of a very high quality. Average temperatures, in the springtime when you can enjoy the wildflowers in this region, range from the low 60s F at night to the mid-70s F during the day. *Complete pre-departure details will be sent to participants.*


